Before joining Toyo University, he was a research fellow at Institute of Developing Economies (IDE-JETRO). He holds his Ph.D. in Economics from Kyoto University and his research field is in Spatial Economics and Development Economics. He has worked on various issues on the relations between the economic geography and the impacts of regional integrations. Some of the examples include the quantitative evaluation of wider economic benefits from international logistics improvements (c.f. highways, railways and ports), trade liberalization, customs facilitations and harmonization, vehicle movement agreements and others. He is currently interested in partition of India as an example of regional disintegration. He also works on other issues such as the maritime transport network evolutions, human trafficking, partition of regions as regional disintegration, and others. Dr. Naoyuki Yoshino is Professor Emeritus at Keio University (Economics), Tokyo, Japan and until March 2020 was Dean/CEO of the Asian Development Bank Institute (ADBI). He obtained his PhD from Johns Hopkins University under supervision of Sir Alan Walters who was an economic advisor to Prime Minister Margaret Thatcher of UK. He received honorary doctorates from University of Goteborg (Sweden) and Matin Luther University of Halle-Wittenberg (Germany). Dr. Yoshino has been a visiting scholar at the Massachusetts Institute of Technology (United States) and a visiting professor at various universities including the University of New South Wales (Australia), Fondation Nationale des Sciences Politiques (France), and University of Gothenburg (Sweden). He has also been an assistant professor at the State University of New York at Buffalo and an economics professor at Keio University (1990-2014). Dr. Yoshino's professional career includes membership in numerous government committees. He was appointed as Chair of the Financial Planning Standards Board in 2007. He has served as Chairperson of the Japanese Ministry of Finance's Council on Foreign Exchange as well as its Fiscal System Council (Fiscal Investment and Loan Program Section). Additionally, he has been a Board Member of the Deposit Insurance Corporation of Japan and President of the Financial System Council of the Government of Japan. He was named Director of the Japan Financial Services Agency's (FSA) Financial Research Center (FSA Institute) in 2020 and is currently an Adjunct Professor at GRIPS and visiting Lecturer at University of Tokyo.
