## Announcing the Fifth CAREC Institute Annual Research Conference

### Theme: CAREC Connectivity: Promoting Trade and Trade Facilitation

The CAREC Institute<sup>1</sup>(CI) is pleased to announce the call for papers and the fifth CAREC Institute Annual Research Conference, which is scheduled for **29-30 May 2025 in Islamabad, Pakistan**. The selected papers will be presented at the fifth CAREC Institute Annual Research Conference. The conference aims to provide a platform for conducting high-quality research on the given topic and an opportunity for research networking.

Potential authors are invited to submit original articles, case studies, and reviews pertinent to the topics elaborated below. The submissions will be commissioned by the Publication Board and External Review Board of the CI, comprising independent reviewers with solid research and professional experience on the topics. Upon acceptance, **the selected manuscripts will be presented at the conference and published as conference proceedings or book.**

#### 1. Background

The CAREC region stands at a pivotal moment, facing critical challenges in connectivity and trade facilitation. Fragmented supply chains, shifting geopolitical dynamics, and the slow adoption of digital solutions hinder seamless trade across borders. Additionally, the urgent need for sustainable and resilient infrastructure demands innovative strategies to enhance regional integration.

Regional collaboration is the key to overcoming these barriers. By strengthening trade corridors, transit development, and customs efficiency, the CAREC region can unlock its economic potential and foster sustainable growth. Green transport solutions, digital trade facilitation, and streamlined border processes are essential to building a more connected and competitive economic landscape.

Pakistan, as a strategic transit hub, plays a vital role in bridging regions through efficient trade routes and transit corridors. Initiatives such as TIR and eTIR offer opportunities to reduce logistical barriers, enhance efficiency, and boost regional trade volumes. Engaging the private sector and leveraging foreign direct investment in green sectors will further drive economic transformation.

Against this backdrop, the ***Fifth CAREC Institute Research Conference*** will serve as a platform to explore these pressing issues. Through two days of in-depth discussions, leading experts, policymakers, and researchers will collaborate to develop evidence-based policy recommendations that rethink connectivity and trade facilitation strategies in the CAREC region. By fostering knowledge exchange and multi-stakeholder dialogue, the conference aims to shape actionable solutions for a more integrated, innovative, and resilient regional economy.

## 2. Theme

The theme of the fifth conference is “**CAREC Connectivity: Promoting Trade and Trade Facilitation**”. The sub-themes are:

- Developments in Border-Crossing Points (BCPs)

### 2. Green Transport and Corridor Development

- Development of efficient and sustainable transport systems
- Opportunities and challenges in green corridor infrastructure
- Policy frameworks for decarbonizing regional transport networks

### 3. Customs Reforms and Efficiency

- Innovative approaches to streamline customs processes
- Cross-border cooperation and capacity building
- Leveraging technology for transparency and operational efficiency
- Showcase of Pakistan Single Window (PSW)

### 4. Energy Transition and Green Investment

- Role of regional partnerships in energy trade and transition projects
- Investment eco-system for Renewable energy and other green infrastructure projects
- Case studies on successful green investment initiatives

### 5. Private Sector Engagement and Regional Cooperation

- Encouraging public-private partnerships in trade and transport development
- Role of private investment in enhancing connectivity and logistics
- Corridor Performance Measurement and Monitoring (CPMM)

### 6. Multimodal Logistics

- Policies, Strategies and Standards to Develop Multimodal Logistics
- Role of the Seaports: Issues, Actions and Investment
- Containerization in the CAREC Region and Multimodal Logistics Center
- Railways – Expanding Freight Traffic and Reshaping Corridors

- Waterways: Time to Rethink Its Potential?



The papers on critiquing the old development paradigms and proposing new development strategies in the CAREC region are welcomed.

### 3. Submission procedure

The CAREC Institutes invites the submission of papers relevant to the above-listed thematic areas. Authors should submit extended abstracts of no more than 500 words by **March 20<sup>th</sup> 2025** to [emmat@carecinstitute.org](mailto:emmat@carecinstitute.org). Notifications of the acceptance of the abstracts will be sent on **March 28<sup>th</sup>, 2025**. First drafts of full manuscripts of 8,000 words maximum, excluding annexes, should be submitted to the same email address **by 12<sup>th</sup> May 2025**.

All submissions are required to include the following information on a separate cover page:

- Title of the paper
- Name(s) of author(s) in intended order of authorship, their organizational affiliation(s), position(s), and e-mail address(es)
- Lead author's telephone number
- Manuscript words count

The language of manuscript submissions and conference presentations is English. All submissions will be thoroughly reviewed by CI's Publication Board and External Review Board members based on the following criteria:

- Significance/contribution to the field
- Relevance to conference theme
- Aims and purposes
- Theoretical foundation
- Methodology
- Results and policy recommendations
- Conclusion
