CAREC Institute Chai Talk: "Green Public Procurement and emerging trends in the CAREC region:

Webinar 23rd April 2025 14:50 – 16:30 (Beijing time)

Background:

Public procurement provides governments with a powerful tool to achieve their development objectives. The estimated global value of public procurement is approximately US\$11 trillion, representing 12 percent of global GDP. In many developing countries, the government is the single largest purchaser for many categories of products and services. Governments are increasingly using this purchasing power as a tool to achieve their economic, social, and environmental goals ¹.

Green Public Procurement (GPP) leverages the public sector's purchasing power to achieve environmental objectives by procuring goods, services, and works with a reduced environmental impact throughout their life cycle. This includes considering factors such as energy efficiency, resource conservation, reduced greenhouse gas emissions, and minimal waste generation. GPP is a key tool for promoting sustainable development and achieving environmental, social, and economic goals. As emerging trends like digitalization, circular economy integration, and climate-centric procurement gain momentum, GPP is poised to play an even greater role in shaping a sustainable future.

The Green Public Procurement (GPP) is an emerging practice in the CAREC region, and the countries showing great efforts aimed at integrating environmental considerations into public procurement processes to promote sustainability. For instance, China's GPP evolution, spanning from the 1990s to the present, demonstrates a strong commitment to sustainable procurement practices encouraging the private sector to invest in more energy-efficient, eco-friendly products, driving green competitiveness and fostering sustainable consumption and production. Public authorities are already aware of the need to optimize value for money of their spending and investment. Mongolia has introduced strategies for Sustainable Public Procurement (SPP) and GPP, aligning with its National Green Development Policy (NGDP) and Sustainable Development Vision 2030. Similarly, Kazakhstan has developed green procurement guidelines as part of its broader environmental strategies, focusing on energy efficiency

and carbon emission reduction. Uzbekistan has also started incorporating sustainability criteria into public tenders, particularly in construction and energy sectors, to support its national green economy goals.

However, challenges such as higher upfront costs, lack of expertise, limited awareness and supplier capacity, insufficient regulatory frameworks, and a lack of market readiness for green products persist across the region. By addressing these barriers, and leveraging emerging trends, GPP can play a pivotal role in fostering a greener, more resilient economy.
